Understanding your rights and responsibilities as a SG Career user.

Terms of Use

This document states the Terms of Use ("Terms") under which you ("You") may use the SG Career Site and the SG Career Services (each as defined below).

These Terms becomes a binding agreement between You and Schoeman Global Career ("SG Career") trading name of Elgator LLC, and are deemed accepted by You each time that You use or access any SG Career Site or SG Career Service. If You do not accept the Terms stated here, do not use the SG Career Sites and the SG Career Service. You understand and acknowledge that You have no ownership rights in Your account. In addition, third parties may retain saved copies of Your Information.

It is US Law on a J1 visa to pay for health insurance while being employed by the employer at the cost of \$300.

SG Career reserves the right to delete Your account and all of Your Information after a significant duration of inactivity.

You must have no criminal convictions. They will be required to provide an Enhanced Disclosure from the Criminal Records Bureau (CRB: (a criminal record check).

You must demonstrate a strong and sincere desire to work with young students from diverse backgrounds.
